So far, 176 units (93%) have submitted at least one report and 73% of units who have reported cases have completed data entry.


Why is complete data entry important?

In our previous studies we have usually had around 90% complete data entry. This really matters because it makes the study more reliable. This means that it is easier to get the study results published and it will have more of an impact on practice - which is why we do this research! Also, for a study like this where we have relatively low numbers of cases it doubly important to have complete data about as many cases

As you will know, we finished active reporting and as possible. So please do everything you can to get database. If you have reported cases in error, please let Alessandra know so that she can delete those cases from the database and stop chasing you.

How to enter data in OpenClinica

If you submit a monthly report including a case, you will be given a case number beginning with AM. We ask for detailed data about these cases, and for one control for each case. You need to enter these data in our database, OpenClinica. The AM id number is the same for both the CASE and the CONTROL. In OpenClinica you need to enter the data for both the case and the control. You need to click on the magnifying lens symbol for both the case and the control to enter data. Data entry is not 'complete', until both case and control are complete. We send monthly email reminders about any incomplete data. If you have data to enter and are waiting for your OpenClinica login details, please contact Alessandra at ukmidss@npeu.ox.ac.uk. Coming in June – Induction of Labour Survey

As the Advanced Maternal age study is coming to a close, we are getting ready for a new exciting project about induction of labour (IOL) in midwifery units. This project was prioritised as a topic for the *NIHR Policy Research Unit in Maternal and Neonatal Health and Care*.

Why this survey?

The proportion of births that occur following induction of labour has been increasing in the UK for at least the past ten years. About a third of labours were induced in 2021-22 in England, compared with 22% in 2011-12. In 2018/19 40% of local midwifery unit admission guidelines indicated that women having IOL (with one 'intervention') were either explicitly eligible for midwifery unit birth or might be admitted following individual assessment. The current extent of this practice, admission policies to a midwifery unit in relation to components of IOL, and outcomes are unknown. Our national survey of practice will describe practices around admission of women to midwifery units following IOL (either inpatient or outpatient).

Will we be reporting cases?

Alongside the survey, we will also send reports request for 3 months, similar to monthly reporting for our previous studies.

This is to try and capture the number of women who are admitted to a midwifery unit after any component of induction or who had any component of induction in the midwifery unit. We will not need any labour and birth data entered on OpenClinica for the women reported – we will just be asking for numbers.

We will use the results of the survey and the three-month reporting to decide whether there is scope to carry out a bigger study looking at outcomes for women admitted to midwifery units following cervical ripening or other components of induction of labour.

When will we get the survey invite?

We are planning to send the survey invite to all UKMidSS reporters at the beginning of June.

New paper: Postnatal care in Midwifery Units

Some of you who have been with us for a while might remember that, back in 2022, then MSc student midwife Imogen Graham from Oxford Brookes University worked with us on a survey looking at postnatal care in midwifery units. The aim of the survey was to describe the scope of postnatal services provided by midwifery units across the UK, both before and since the pandemic, with the aim of informing service and good practice guidance development. Imogen is now a qualified midwife and we're delighted to say that the results of the study have now been published and are available *here*. Our paper describes the ways in which postnatal care provision differs between AMUs and FMU, with potential consequences for choice and experience for women. We also found evidence that maternity care was adversely affected by the COVID-19 pandemic, including a reduction in postnatal visiting for partners and in postnatal group support services



UKMidSS Study Day

Midwifery Student Internship



Alessandra, UKMidSS Research Midwife, has been awarded funding in the first round of the National Institute for Health and Care Research (NIHR) Undergraduate Internship Programme which will support the hosting of a student midwife with UKMidSS later in June. The funding provided by the new scheme, which is designed to engage and attract students from underrepresented professions to consider a career in research, will enable a student midwife to undertake a paid internship for two weeks with us! We are holding the interviews this week, and looking forward to welcoming them later in June.
